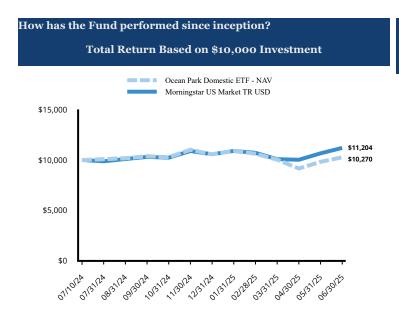
#### How did the Fund perform during the reporting period?

Had the Fund been open the full reporting period, expenses would be higher.

For the period ended June 30, 2025, the Fund's return was positive on an absolute basis. However, the Fund underperformed its primary benchmark index during the period.

During the second quarter of 2025, following the Trump Administration's 'Liberation Day' tariffs announcement, a sharp correction in U.S. equities prompted the Fund to fully exit its holdings and move to 100% cash and cash equivalents. This market correction proved relatively shallow, and a sharp rally began shortly after the Fund reduced its equity exposure. The Fund did not participate in the early stage of the market which impacted the relative performance until Buy signals were triggered upon identification of new uptrends.

Large cap growth, large cap value, mid cap and small cap funds were the largest contributors towards the Fund's performance on an absolute basis. The Fund's large cash position also contributed positively towards the Fund's performance. Large cap blend funds were the largest detractor towards the Fund's performance during the period.
